This includes \$3,988.1M for the Facilities Sustainment, Restoration and Modernization (FSRM) program that had new obligations of \$2.5M; \$757.1M for the Military Construction (MilCon) program that had new obligations of \$18.6M; \$279.5M for the Near Term Energy-Efficient Technologies (NTEET) program; \$92.1M for the Energy Conservation Investment Program (ECIP); and \$462.6M for the Homeowner's Assistance Program (HAP) that had new obligations of \$11.1M. Total obligations to date reflect over 4,900 contract actions with non-Federal vendors. Over 74% of contract actions were to small businesses (57% of contract dollars).
