This includes \$3,991.9M for the Facilities Sustainment, Restoration and Modernization (FSRM) program which had an increase of \$.2M for the week; \$1,859.8M for the Military Construction (MILCON) program ; \$117.3M for the Energy Conservation Investment Program (ECIP); \$297.9M for the Near Term Energy-Efficient Technologies (NTEET) program; and \$555.0M for the Homeowner's Assistance Program (HAP). Adjustments were made to MILCON and ECIP to reflect the correct amount, for Treasury Account Funding Symbol(TAFS) 97-0501 (MILCON decreased \$10.2M and ECIP increased \$9.9M). On August 10, 2010, Congress rescinded \$260.5M of Recovery Act funds in Public Law 111-226, reducing the total DoD Recovery Act funding to \$7.175B. Total obligations to date reflect over 6,700 contract actions with non-Federal vendors.
