1	The Department of Defense (DoD) had obligations of \$32.0M during the week ending May 7, 2010, bringing the cumulative obligation of Recovery Act funds to \$4,925.2M, which is 66.2% of available DoD Recovery Act funds. This includes \$3,707.4M for the Facilities Sustainment, Restoration and Modernization (FSRM) program that had new obligations of \$20.4M; \$675.9M for the Military Construction program; \$264.1M for the Near Term Energy-Efficient Technologies (NTEET) program; \$64.0M for the Energy Conservation Investment Program (ECIP); and \$213.9M for the Homeowner's Assistance Program that had new obligations of \$10.5M. Total obligations to date reflect over 4,200 contract actions with non-Federal vendors. Over 73% of contract actions were to small businesses (55% of contract dollars).	Continue to award contracts and monitor execution.
2	The \$20.4M increase in FSRM obligations includes \$14.9M for the Army, and \$4.4M for the Navy. Army obligations included \$8.5M for building system upgrades at Camp Shelby, MS; \$2.5M for heating, ventilation, and air conditioning projects at multiple Army National Guard sites in AK; and \$1.3M for barracks renovations at Ft. McCoy, WI. Navy obligations included \$2.4M for advance meter installations at multiple sites in CA; and \$1.7M for runway repairs at Naval Air Station Oceana, VA.	
3	The Homeowner's Assistance Program had \$10.5M in new obligations that were primarily payments to service members and their families.
