1	The Department of Defense (DoD) obligated \$31.1M during the week ending October 16, 2009, bringing the cumulative obligation of Recovery Act funds to \$3,368.7M, which is 45.4% of available DoD Recovery Act funds. This includes \$2,599.8M for the Facilities Sustainment, Restoration and Modernization (FSRM) program which had new obligations of \$29.7M this week; \$582.1M for the Military Construction program; \$143.8M for the Near Term Energy-Efficient Technologies (NTEET) program which had new obligations of \$0.3M; \$36.2M for the Energy Conservation Investment Program (ECIP); and \$6.8M for the Homeowners Assistance Program including \$1.1M in new obligations. Total obligations to date reflect over 2,500 contract actions with non-Federal vendors. Over 76% of contract actions were to small businesses (58% of contract dollars).	Continue to award contracts and monitor execution.
2	There were an additional \$29.7M in new obligations on FSRM projects for the week including \$16.3M for Defense -wide projects \$9.8M for Navy projects; \$2.6M for Army projects and \$0.9M for Air Force projects. For the week, Defense-wide obligations included \$8.5M for 5 repair projects at the National Naval Medical Center, Bethesda, MD; \$1.4M for repairs to the medical building at the Naval Air Station, Corpus Christi, TX; and \$0.6M for 2 projects at the Navy Medical Center, San Diego, CA. Navy obligated \$9.8M to repair runway 5R/23L at Naval Air Station Oceana, VA. The Army obligations included \$1.4M for Non-Commissioned Officers Academy repairs at Schofield Barracks, HI and \$0.7M for roof repairs at Fort Huachuca, AZ. Air Force FSRM obligations included \$0.8M for facility and utility projects at Malmstrom Air Force Base, MT.
