1	The Department of Defense (DoD) obligated \$99.7M during the week ending May 22, 2009, bringing the cumulative obligation of Recovery Act funds to \$459.3M. The \$459.3M in obligations represent 6.2% of all DoD Recovery Act Funds received and reflect almost 500 contracts to non-Federal vendors. Of the contracts awarded, over 87% were awarded to small businesses (over 70% of contract dollars).	Continue to award contracts and monitor execution.
2	The Army obligated \$33.9M this week for a cumulative obligation total of \$98.2M. Contracts awarded this week include multiple Facilities Sustainment, Restoration and Modernization (FSRM) projects at Anchorage, AK, Fort Lee, VA and Fort Knox, KY	The military services are currently working on the internal management control review and gap analysis process as part of DoD Force Risk Management Plan. Service inputs will be provided to the Department shortly.
3	The Department of the Navy obligated \$3.3M this week for a cumulative obligation total of \$100.9M. These obligations include funds for pre/post award contract support projects.	Complete proposed rule for the Homeowners Assistance Program (HAP) and submit to the federal rulemaking process.
4	The Air Force obligated \$61.4M this week for a cumulative obligation total of \$255.8M. The contracts awarded this week include FSRM projects at Eielson Air Force Base (AFB), AK, Kirtland AFB, NM, Robins AFB, GA.	
5	The U.S. Army Corps of Engineers (USACE) obligated \$1.1M this week for a cumulative obligation total of \$4.4M related to start up and administrative costs associated with the Homeowners Assistance Fund.	
6	The Department completed its Agency Wide Recovery Act Plan and submitted to the Office of Management and Budget (OMB). OMB approved four of the five plans for posting to recovery.gov. The remaining plan on Homeowners Assistance Program will be completed shortly. The approved plans are now posted on the DoD Recovery Act website as well as recovery.gov.	
7	The Deputy Secretary of Defense signed out final guidance on the Homeowners Assistance Program on May 14. On the same day the Vice President announced the program during a Navy visit in San Diego, CA followed by a Department of Defense press release.
