1	The Department of Defense (DoD) obligated \$63.8M during the week ending May 29, 2009, bringing the cumulative obligation of Recovery Act funds to \$523.7M. The \$523.7M in obligations include \$467.0M for Facilities Sustainment, Restoration and Modernization (FSRM) program, \$2.9M for the Homeowner Assistance Program (HAP), \$37.8 for the Military Construction Program, and \$15.9M for Near Term Energy-Efficient Technologies Program. These obligations represent 7.1% of all DoD Recovery Act Funds received and reflect over 500 contracts to non-Federal vendors. Of the contracts awarded, over 86% were awarded to small businesses (73% of contract dollars).	Continue to award contracts and monitor execution. DoD is convening a 1 June meeting to discuss ways to accelerate obligations by making process changes to pre and post-award plans.
2	The Army obligated \$17.4M this week for a cumulative obligation total of \$115.6M. Contracts awarded this week include multiple FSRM projects including \$10.9M for the Army National Guard.	The military services are currently working on the internal management control review and gap analysis process as part of DoD Risk Management Plan. Service inputs will be provided to the Department shortly.
3	The Department of the Navy obligated \$1.6M this week for a cumulative obligation total of \$102.6. These obligations are primarily for pre/post award contract support projects.	Complete proposed rule for the Homeowners Assistance Program (HAP) and submit to the federal rulemaking process.
4	The Air Force obligated \$44.5M this week for a cumulative obligation total of \$300.3M. The contracts awarded this week include multiple FSRM projects at Dyess Air Force Base (AFB), TX for \$10.2M; Elmendorf AFB, AK for \$6.7M; Edwards AFB, CA for \$3.8 M; Malmstrom AFB, MT for \$1.4M; Vandenberg AFB, CA for \$3.2M; Maxwell AFB, AL for \$2.5M; US Strategic Command Offutt AFB, NE for \$2.1M; and Barksdale AFB, LA for \$3.4M.	
5	The U.S. Army Corps of Engineers (USACE) obligated \$0.3M this week for a cumulative obligation total of \$2.9M related to start up and administrative costs associated with the Homeowners Assistance Program (HAP). Last week's HAP obligations were over reported on the major completed action items by \$1.9M.
