1	The Department of Defense (DoD) obligated \$224.5M during the week ending July 3, 2009, bringing the cumulative obligation of Recovery Act funds to \$1,300.2M. The \$1,300.2M in obligations include \$1,140.2M for the Facilities Sustainment, Restoration and Modernization (FSRM) program, \$110.2M for the Military Construction Program, \$46.1M for the Near Term Energy-Efficient Technologies Program and \$3.5M for the Expanded Homeowners Assistance Program (HAP). These obligations represent 17.5% of all DoD Recovery Act Funds received and reflect over 1,140 contracts to non-Federal vendors. Of the contracts awarded, over 82% were awarded to small businesses (65% of contract dollars).	Continue to award contracts and monitor execution with a target of \$1.9 billion in military construction and facility repair work underway by August 31.
2	The Army obligated \$34.3M this week, for multiple FSRM projects, for a cumulative obligation total for all programs of \$314.8M. Obligations included \$6.0M for repairs at the Aberdeen Proving Grounds, MD; \$3.3M for electrical and steam line repairs at Anniston Army Depot, AL; \$0.4M for repairs to a maintenance facility at Ft. Knox, KY; and \$21.3M in cooperative agreements by the Army National Guard with states including \$2.2M with ND, \$1.5M with CO, \$3.6M with VT, \$3.4M with AZ, \$3.3M with IA and \$4.3M with KY. The amount of new obligations was reduced due to an accounting error of approximately \$0.1M.	The Expanded Homeowners Assistance Program has received over 3,100 applications with 98% being in the Permanent Change of Station category. The applications will begin to be processed after the Interim Final Rule is published in the Federal Register for public comment, which is expected in the next few weeks.
3	The Navy obligated \$123.2M this week for a cumulative obligation total of \$277.5M. New obligations of \$109.6M were for multiple FSRM projects including \$79.4M for installation of photovoltaic systems at multiple sites in six states including Florida (\$33.3M), Mississippi (\$13.3M), Texas (\$20.0M), California (\$4.2M), Washington, DC (\$2.5M), and Maryland (\$6.1M); and repair projects at Camp Lejeune, NC for \$13.4M. The Navy also had an additional \$13.6 in Military Construction Projects including \$7.3M for upgrades to facilities and photovoltaic systems at Camp Lejeune, NC and \$3.1M for bachelor quarters housing at Marine Corps Air Station, New River, NC. The remaining obligations are for multiple smaller projects and for pre/post award contract support.	
4	The Air Force obligated \$48.5M this week for a cumulative obligation total of \$676.9M. The \$48.5M for current week obligations included \$46.1M for multiple FSRM projects and \$2.4M for Near Term Energy-Efficient Technologies Program. The obligations for FSRM projects included \$8.5M for energy, roofing, utilities, pavements and facility improvements at Moody AFB, GA; \$1.2M for energy, roofing, and facility projects at Kirtland AFB, NM; \$3.0M in energy projects at Minot AFB, ND; \$2.8M in energy projects at Randolph AFB, TX; \$1.3M in energy and facility projects at Ellsworth AFB, SD; and \$1.5M for pavements at March Air Reserve Base, CA. The Near Term Energy-Efficient Technologies projects include \$1.9M for High Efficiency Portable Fuel Cells, \$0.3M for Adaptive Versatile Engine Technology, and \$0.2M for Small Business Innovation Research/Small Business Technology Transfer.	
5	The Tricare Management Agency had obligations of \$18.6M for multiple projects including \$14.8M to modernize inpatient clinics and perform asbestos abatement at Patrick AFB, FL; and \$3.7M to replace flooring at the Womack Army Medical Center, Ft. Bragg, NC.
